Disclosure Notes on SHP

Please note that the Demat holding of Late Mr. Paresh Rajde is 131 shares as per the Benpos Received from our RTA, Link Intime India Pvt. Ltd. and remaining 16860 shares are in physical form and are in process of transmission. Therefore total shares held are 16991, which are same as per SHP.

Our Promoter (Late) Mr. Paresh Rajde was holding 8,04,19,571 equity shares of Suvidhaa Infoserve Limited, However upon his demise and during the process of share transmission to Mrs. Sonal Rajde (Wife of Mr. Paresh Rajde and Nominee) 8,04,02,580 shares were transmitted in the name of Mrs. Sonal Rajde and remaining 16,991 shares could not transmitted then due to the frozen ISIN. Therefore, disclosure of 16,991 shares (Including 131 shares in Demat form) is rightly mentioned in SHP.

Also, during the process of Scheme of arrangement approved by Honble NCLT, Ahmedabad, shares shown in SDD 19281 are the shares which were credited to the Demat Account (Special Account) of Mr. Paresh Rajde Jt. With Prashant Thakar, this is an escrow account for the fractional entitlement of shares that arose pursuant to scheme of arrangement. The correct number of shares credited for fractional shares was 19150 shares however due to inadvertence 131 Shares were held in personal capacity as a promoter by Mr. Paresh Rajde was included in the total number of shares.

Therefore, number of shares held by Late Mr. Paresh Rajde in his personal capacity was 16991 and shares held in aforesaid special account for fractional entitlement of shareholder was 19150 which shall not be considered to be promoters own holding.
